MINUTES OF THE MEETING HELD UNDER THE CHAIRMANSHIP OF SECRETARY (DA&FW) WITH AER CENTRES / UNITs ON 08th JUNE 2023

At the outset, Shri Arun Kumar, Sr. ESA, E&S Division welcomed the Chair (Secretary, DA&FW) and participants from AERCs/Us. He outlined briefly the functioning of AERCs/Us and staff issues being faced by them. He also mentioned that expertise of AERCs/Us may be utilized in line with the needs and priorities of the Ministry. Thereafter, he requested the Chair to address the gathering.

- Shri Manoj Ahuja, Secretary, DA&FW extended a warm welcome to all the participants. He mentioned that the very purpose of the meeting is that the AERCs/Us play vital role on academics front as well as getting feedback from the field. These feedback are useful for efficient & effective implementation of the schemes and their midcourse correction. Secy (DA&FW) suggested for convening conferences, work-shops, seminar etc. annually with all stakeholders, including the representatives of State Government and Universities. He also suggested to bring out 2-3 page policy brief along with the study report. He also assured the participants that research institutions would be strengthened and the staffing issues of AERC/Us would be resolved at the earliest. Thereafter, he invited the AERC/Us participants to share their views/suggestions.
- Dr. Ajit Ranade, Vice-chancellor, Gokhale Institute of Politics and Economics endorsed the views expressed by Secretary (DA&FW) and Sr. ESA. He emphasized on the New Education Policy on experiential learning. He further stated that AERC Pune would be celebrating 'Platinum Jubilee' in the year 2024, wherein a conference/meeting could be organized. Secretary, DA&FW agreed to the request for marking the occasion. He also suggested sharing the success stories/best practices from the ground.
- 2.2 Prof. Jayanti Kajale, Director, AERC Pune, GIPE briefly mentioned about the institute and insights into knowledge gained during the studies assigned by the Ministry. These serve as valuable inputs to the teaching and academia. She also shared the feedback on pilot survey conducted on the Agri Infrastructure Fund scheme and raised concerns about shortage of staff.
- 2.3 Prof. Brajesh Jha, Head, AER Unit, Institute of Economic Growth, Univ. of Delhi outlined the performance of the Unit from the last work plan. He informed that with regard to the concurrent evaluation project, the Unit has been assigned two schemes/programmes, viz. Agri. Marketing (ISAM) and e-NAM. He informed that a small pilot survey has been undertaken and suggested closed ended questions instead of open ended questions for the questionnaires.
- 2.4 Prof. Ranjan Ghosh, Chairperson, CMA IIM-Ahmedabad informed that CMA brings out the Agro-Economic Policy Briefs and Alerts alternatively every three months. Brief brings out the

outcome of studies undertaken by AERCs/Us while Alert focuses on live agricultural issues and concerns. These are circulated to the PMO, Ministry of Agriculture and all stakeholders. He also informed about the publication of Agro-Economic Research outputs in well renowned academic journals and suggested that the same needs to be disseminated to a wider audience through social media such as LinkedIN, Twitter etc. The same may be re-tweeted at the Ministry level for better visibility and impact.

- 2.5 Prof. Ramappa K.B., Head, AER Unit, ADRTC, ISEC Bengaluru shared the findings of the pilot survey. He emphasized on the need for corrections with regard to extension services and creating awareness about the Schemes of the Ministry. Secretary, DA&FW suggested having Georeferenced, time-stamped activities while delivering services for better monitoring and evaluation.
- 2.6 Prof. S.Chinnammai, AERC Chennai, University of Madras talked about the Centre and the academic output. She also informed about the recently held Governing Body Meeting at the Centre and the issues discussed therein. She also shared her concern on shortage of staff and payout to contractual staff at AERC Chennai. She also informed about the village surveys undertaken by the Centre over the years. Secretary, DA&FW also stressed on the relevance of assessing important changes that have occurred over time through longitudinal survey.
- 2.7 Prof. S.S. Kalamkar, Director, AERC V.V.Nagar briefed about the Centre's activities and the studies undertaken by the Centre. He also informed the participants about the praiseworthy remarks made by Hon'ble Prime Minister of India for the Centre. He also raised the issue of shortage of staff along with nomenclature of posts in the AER Centre. Secretary, DA&FW suggested to re-look the nomenclature of posts / staff structure in line with contemporary needs.
- 2.8 Dr. Hari Om Sharma, Director, AERC Jabalpur and Dr. Deepak Rathi briefly mentioned about the Centre and its activities. They suggested that the manpower resources of the Cost Study scheme may be utilized for data collection.
- 2.9 Dr. J.M. Singh, Director, AERC Ludhiana, Punjab Agricultural University briefly touched upon work carried out by the Centre. He also informed that the Centre is involved in farmers training, teaching, research etc. and raised the staffing issues at the Centre. It was informed that AERC Ludhiana is involved in the National Mission for Sustainable Agriculture and shared the findings of the pilot survey.
- 2.10 Shri Sreejit Roy, AERC Visva Bharati raised the staff shortage issues and highlighted the challenges posed by Climate Change in the areas of Sunderban region of West Bengal, parts of A&N Islands etc with a request to approve the study proposal submitted for consideration of the Research Advisory Committee.

- 27798/2023 2.11 Prof. Parmjit, Hony. Director and Dr. Yogesh Bhatt, AERC Delhi briefly presented the study completed by the Centre. Dr. Yogesh Bhatt raised the staff shortage concern and requested for multi tasking staff in the Centre.
 - 2.12 Dr. Javed Akhtar, Coordinator, AERC Allahabad raised the staffing concerns and various issues being faced by the Centre including transport facility, etc. He also shared the feedback of the pilot survey with respect to PM KISAN.
 - 2.13 Dr. Rajeev Kumar Sinha, and Dr. Sanjay Kumar Jha, Hony. Director, AERC Bhagalpur requested for permission for at least two research staff for each project to be assigned to the Centre. The stagnation in service career of staff was also raised with special mention about the nomenclature and shortage of staff.
 - 2.14 Prof. H Purushottam, Hony. Director, AERC Waltair opined about the need for better interaction among the AERC/Us network. He requested for provisioning of interns in AERC/Us. Hony. Director also suggested looking into the release of funds in time for proper utilization of funds allotted. J.D. (AER) informed that the delay is due to the Single Nodal Agency aspect in the PFMS facility and all out efforts are being taken to release the funds at the earliest.
 - Dr. A.K. Das, Hony Director, AERC Jorhat on the feedback of pilot survey mentioned that some of the components of the schemes are in duplication (eg. NMSA), hence, convergence is required. He also informed about the staff issues with the Centre with long pending vacancies. Sr. ESA enquired whether the deemed abolished posts if revived would be filled by the host University/ Institutions. Dr. Das informed that despite advertisements for posts, the Centre does not get the right candidates, hence, it remains vacant. V-C, GIPE suggested making contractual arrangements such as sabbatical/ lien may be allowed so that the posts don't fall under deemed abolished category, meanwhile the Centre can keep on advertising for filling-up the posts. Dr. Das stressed on the need for involving the state machinery while allocating the studies. A letter from the Ministry to Chief Secretary may be issued for facilitating survey research.
 - 2.16 Dr. Nisha Devi, Research Investigator, AERC Shimla informed about the non-permanent Director at the Centre and staff shortage.
 - 3. The following action points emerged during the meeting:
 - i. Organise an annual conference with all stakeholders, including the representatives of State Government and Universities. (Action: AERC/Us)
 - **ii.** Prepare a proposal for hosting / organizing seminar/workshops/capacity building programmes within/among AERC/Us and with stakeholders twice in a year for submission

- to Ministry. (Action: AER Unit CMA IIM Ahmedabad).
- iii. To take up the issue of revival of the posts fallen under deemed abolished category and resolve the same within 2-3 months time. (Action: AER Section, E&S Division).
- iv. Clarification by the Ministry on nomenclature of posts in AER Centres/Units, TA, DA, etc. (Action: AER Section, E&S Division).
- v. Extending necessary support including authorization letters from Ministry to State Governments for facilitating the activities of AER Centre/Unit. (Action: AER Section, E&S Division).
- vi. To bring out 2-3 page policy briefs for dissemination among the stakeholder widely.

 (Action: AERC/Us)
- vii. Dissemination of the research outcome to a wider audience through social media for better visibility and impact. (Action: AERC/Us and E&S Division, DA&FW).
- viii. Formation of a Sub-Group Committee within AERC/Us network to monitor the progress of the feedback mechanism and evaluation of schemes. (Action: AER Units and AERC V.V.Nagar, and AER Section, E&S Division).
 - ix. Sharing of the success stories/best practices from the ground. (Action: AERC/Us)
 - x. Set up an Online Search Enabled Metadata option for accessing the research reports completed by the AER Centres and Units. (Action: AER Section, E&S Division, and NIC, DA&FW/DA (IT) Division, DA&FW).
 - xi. A Conference would be organized during Platinum Jubilee Celebration of AERC, Pune in 2024. (Action: AERC, Pune)
- 4. Sr. ESA thanked all the participants for their active participation in discussions and suggestions. The meeting concluded with a Vote of Thanks to the Chair.
