- i) AERC proposed coverage of 7 states. RFS Division suggested increasing the coverage to 9 States (Jharkhand, Gujarat, Maharashtra, Uttar Pradesh, Arunachal Pradesh, Karnataka, Rajasthan, Madhya Pradesh and Uttarakhand) and to focus on Drip and Sprinkler irrigation systems.
