Minutes of the meeting held under the Chairmanship of Secretary, DA&FW

A meeting on concurrent feedback system/ impact assessment was held under the Chairmanship of Shri Manoj Ahuja, Secretary, DA&FW to discuss the status of selected schemes for concurrent feedback survey on 22nd August, 2023 at 3:30 P.M.in Room No. 138, Krishi Bhawan. The list of participants is at **Annexure I**.

- 2. At the outset, the Chair was apprised of the status of each scheme selected for concurrent feedback. It was explained that various parameters taken into account for feedback survey, inter-alia, include target population, state coverage, sample size, questionnaire. The selected sample size adequately represents the target population.
- 3. Presentation on detailed status of questionnaire, number of questions, target population, sampling methodology, sample size etc. for each of the scheme was made. Availability of state/district/village counts and beneficiary list of scheme were also indicated. It was mentioned that information with respect to target population, states coverage, state/district counts have been received for all the schemes except SHC and KCC. The representatives of these two Divisions assured that the requisite information will be made available at the earliest.
- 4. A detailed discussion took place on the process as well as on the execution of the survey of selected schemes. It emerged in the meeting that the survey may be conducted in a phased manner due to variability in the nature of the schemes, its spatial coverage across the country, target population, sample size etc. A few schemes like AIF, PMFBY, KCC, MIDH & PMKISAN may be taken up in the first phase and for remaining schemes, User Acceptance Test(UAT) may be conducted on a pilot basis with sample size of 50 to 100 and 2022-23 as reference year. It was informed that AIF Division has already proceeded with

the feedback survey of AIF scheme which is to be completed on an urgent basis within 45 days. In the meeting, it was suggested to document the entire exercise of concurrent feedback survey/ impact assessment. This would facilitate institutionalization of the feedback system. Towards this, a booklet is to be prepared which, inter-alia, may include conceptual exposition on concurrent feedback, its need and objectives, sampling framework/methodology, sample size, questionnaires, funding mechanism, scheme specific details and role of AERCs.

- 5. Secretary enquired about the cost and mechanism of flow of funds for carrying out the survey work. It was informed that cost per questionnaire has already been fixed by the Committee constituted for this purpose. Scheme-wise accounts will be opened with respective AERCs/Us for smooth flow of funds for survey work. It was suggested that AERCs/Us may, if required, outsource the survey works following the due process as per rules & regulations of the university/ institute to which they are attached to. An estimated cost of survey for aggregate sample size of all schemes was placed in the meeting. It was broadly agreed that the estimated cost was reasonable and economical.
- 6. Consultant, IT Division apprised of the progress of the mobile App development. She informed that all questionnaires received had been converted to application format. Questionnaires with respect to four schemes i.e. PMFBY, SHC, MIDH and KCC had been loaded in the App. Further, Web Development has already started and the Mobile App development will be completed by 20th September 2023.
- 7. The following decisions and action points emerged during the meeting:
 - a) The concurrent feedback/impact assessment of schemes will be undertaken in phases. In the first phase, five schemes viz. AIF, PMFBY, KCC, PM-Kisan and SMAM will be taken up for feedback survey.

b) For the remaining schemes viz. SHC, MIDH, NFSM, PDMC & e-

NAM, UAT will be conducted on a pilot basis with sample size of 50 to

100. After analyzing the outcome of UAT, these schemes will be taken up

for concurrent feedback survey in the second phase. Sample size is shown

in table at **Annexure –II**.

c) AERCs/Us may outsource the data collection work following the due

process.

d) The entire exercise of concurrent feedback survey/ impact assessment

to be documented. A booklet containing conceptual exposition on

concurrent feedback, its need & objectives, target population, sampling

methodology, sample size, questionnaires, mobile App, funding

mechanism, scheme specific details and role of AERCs will be prepared.

e) Development of Mobile App for the feedback survey to be completed

by IT Division by September, 2023.

The meeting ended with a Vote of Thanks to the Chair.
