Subject: Minutes of 19th Meeting of Coordination Committee for Organization of Studies (CCOS) held on 18th November, 2015 for allocation of studies to Agro-Economic Research Units/ Centres.

The 19th meeting of Coordination Committee for Organization of Studies (CCOS) in the field of agricultural economics was held at Krishi Bhawan, New Delhi on 18th November, 2015. The meeting was chaired by Secretary, Department of Agriculture, Cooperation & Farmers Welfare. Chairman welcomed the participants and Member Secretary and Shri P.C. Bodh, Adviser, Agro Economic Research Division, Directorate of Economics and Statistics (DES) gave a brief on study proposals received from various Ministries/ Departments. Member Secretary explained that the CCOS has to decide the Studies to be taken up for the period ending March 2017, the terms of reference and geographical coverage of allotted studies and also specific AER units/centres to whom these studies to be allotted. The list of participants is annexed. The discussions and decisions taken are summarized below.

2. Secretary (AC&FW) emphasised the need for timely completion of studies so that their recommendations could be useful for policy intervention. He directed that a soft copy of all completed studies should be uploaded on the websites of the DAC&FW as well as the DES. He suggested that studies should be published in more effective manner. Adviser (AER) has stated that completed studies are circulated to all concerned and are also placed on the website of the Universities/Institutes with hyperlink to the website of the Directorate of Economics & Statistics. However, in consultation with NIC, action will be taken to provide a list, searchable by keywords, on the DAC& FW website.

(**Action:** All AER units/Centres to ensure uploading of completed studies on their respective websites by December, 2015; AERC Division)

3. The Committee was briefed on the review of Current Work Plan of Agro Economic Research Centres (AERC) for the year 2015-16. It was informed that 30 studies have been completed during 2014-15. In the current year 2015-16, 17 studies have been completed till date and the remaining 28 pending studies are at near completion and are likely to be completed by March, 2016.

(Action: All Units/Centers to submit pending studies by February 2016)

4. As regards the proposal for the Work Plan 2016-17, the Committee was informed that a total of 49 Study proposals were received from various divisions of Department of Agriculture, Cooperation & Farmers Welfare, Departments Animal Husbandry, Dairying & Fisheries, Department of Agricultural Research and Education, Ministry of Food Processing Industries, and Agro-Economic Research Units and Centres. The proposals were examined from the angle of relevance of the subjects, studies on similar issues had been done earlier and overall work load based on priority. Out of these, Directorate has shortlisted 24 study proposals after detailed examination and placed these before the Committee for approval along with other proposals.

- 5. The Committee has decided that the objectives, coverage and methodology of the allocated studies will be designed by the concerned AER Units/Centres and finalized within a month after detailed discussion in a meeting for finalisation of allocation of work and methodology where Directors of concerned Units and Centres, experts and representatives of DAC&FW would be present. This meeting will be convened by Directorate of Economics & Statistics at IEG, Delhi. Based on the detailed discussion that followed the Chairman's remarks on various proposals, the following studies were approved:
 - 1. Farmers Suicides- Indebtedness as Major Cause. An All-India study covering all states affected by farmers' suicide will be coordinated by Agricultural Development and Rural Transformation Centre (ADRTC), Bangalore. It was discussed that the scope needed to go beyond merely studying indebtedness.

(**Action:** ADRTC Unit for necessary coordination/preparation of study design.)

2. Wholesale and Retail Prices - differences in CPI, WPI and how to cover the spikes. This all India study will be coordinated by IEG, Delhi.

(Action: IEG, Delhi for coordination/preparation of study design.)

3. Assessment of effectiveness and utility of Kisan Call Centre (KCC), Kisan Knowledge Management System (KKMS) and SMSs through m-Kisan Portal. Three proposals of the IT Division, DAC&FW on similar issues were clubbed into one comprehensive all India study to be coordinated by CMA, IIM, Ahmedabad.

(Action: CMA, IIMA for coordination/preparation of study design.)

4. Assessment of the status of dairying in the eastern states, and potential to improve socio-economic status of milk producers and convergence of all central and sate schemes at district level. Simlar proposals of National Dairy Development Board and AERC Gujarat were clubbed in this study. This study will be coordinated by AERC, V.V. Nagar in consultation with CMA, IIM, Ahmedabad covering 8 states/regions ie Assam, Chhattisgarh, Jharkhand, Odisha, Eastern UP, West Bengal, Gujarat and Rajasthan.

(Action: AERC, VV Nagar for coordination/preparation of study design)

5. Impact of agricultural extension services to farmers by Agri-Clinics and Agri-Business Centres (ACABC) Scheme. This study will be coordinated by AERC, Allahabad covering 3 states of Andhra Pradesh, Gujarat and Uttar Pradesh. JS (IT) will provide inputs on distribution of Agri-clinics and agribusiness ventures established in different States of the country.

(**Action:** Director, AERC, Allahabad for coordination/preparation of study design; JS (IT)/ Adviser (AER)

6. Employment Scenario in Food Processing Sector with focus on women.

An all-India study on secondary database on employment in food processing

sector and gender equity in employment. This all India study will be coordinated by IEG, Delhi.

(Action: IEG, Delhi for coordination/preparation of study design)

7. Impact Assessment of Crop Insurance. An all-India study on secondary database will be coordinated by CMA, IIM, Ahmedabad. JS (Crops) and JS (Insurance) will provide inputs for finalisation of objectives.

(Action: CMA, IIMA for coordination/preparation of study design; JS (Crops)/ JS (Insurance)

8. Comprehensive Study on Pulses – impact of strategies for growth, dynamics and revival of fallow lands and how fallow land can be used for increase in the production of pulses and other crops. This study will be coordinated by IEG, Delhi covering the three states of Tamil Nadu, Maharashtra and Chhattisgarh.

(Action: IEG, Delhi for coordination/preparation of study designs; JS (Crops) will provide relevant inputs.)

9. Assessment on Performance of Indigenous versus Imported Seedlings of Oil Palm. This study will be coordinated be ADRTC, Bangalore covering 3 states of Andhra Pradesh, Karnataka and Tamil Nadu with the help of respective AERCs.

(Action: ADRTC, Bangalore for coordination/preparation of study design)

10.Impact of Protected Cultivation under Mission for Integrated Development of Horticulture (MIDH) This study will be coordinated by AERC, Shimla covering 3 states of Himachal Pradesh, J&K and Sikkim with the help of respective AERCs.

(Action: AERC, Shimla for coordination/preparation of study design)

11.Working and Impact of Pressurised Irrigation Network System (PINS) in Rajasthan. This study will be coordinated by AERC V.V. Nagar covering 3 states of Rajasthan, Gujarat and Maharashtra, with association of AERC, Pune.

(Action: AERC V.V. Nagar for coordination/preparation of study design.)

12. Estimation of losses of pulses focus on all related aspects including losses by blue-bulls in Uttar Pradesh. Approved as a single study covering the Uttar Pradesh focusing on all related issues by AERC Allahabad.

(Action: AERC Allahabad for coordination/preparation of study design)

13. Evaluation of arsenic content in rice varieties and hybrids focus on indigenous rice varieties in Sundarban delta in West Bengal. Similar proposals of NFSM Cell and AERC Visva-Bharti were clubbed in this study.

Approved as a single study to AERC, Visva-Bharti, Shantiniketan for West Bengal.

(Action: AERC, Visva-Bharti, Shantiniketan for coordination/preparation of study design)

14. Economic Analysis of Cost & Return of protected cultivation vegetables focus on Greenhouse effect. This study will be coordinated by AERC, Shimla covering the 4 states of Himachal Pradesh, Jammu & Kashmir, Uttarakhand and Sikkim. Horticulture Commissioner may be consulted before finalisation of methodology of the studies.

(Action: AERC Shimla for coordination/preparation of study design in consultation with Adviser (Horticulture)

15. Status and Utilization pattern of Input Subsidies in Punjab Agriculture. Approved as a single study to AERC, Ludhiana for Punjab.

(Action: AERC, Ludhiana for coordination/preparation of study design)

16.Problem and Prospects of Production of small Millets and their value added products. Approved as a single study to AERC, Jabalpur for Madhya Pradesh.

(Action: AERC, Jabalpur for coordination/ preparation of study design.)

17. Part A: Assessment of the impact of Neem-coated Urea on the production and productivity of major crops in the selected States. Part B: Bench mark study on Soil Health Card Scheme implemented since 2015-16 for creating baseline data for future evaluation of the **scheme.** The study assigned to Centre for Management in Agriculture (CMA), IIM, Ahmedabad with participation of AERC centers in the selected States. Part A of study was submitted after CCOS meeting. The need of this study was raised by JS, Department of Fertilizers at a time of discussion held in the CCOS meeting. The committee, however, felt that Neem-coated Urea has just been introduced and it will be early to study the impact. Moreover, Department of Fertilizers had not given any proposal to DES. However, on the intension of JS (Fertilizers) Chairman directed JS (Fertilizers) to give a proposal so that it could be inducted in the list of studies to be conducted. However, Department of Fertilizers has submitted a proposal outline on 23rd December. 2015 additional inputs are still awaited. Part B of the study was included as per discussion with JS (INM), DAC&FW, according to Secretary's instruction in SOM on 1.12.2015.

(Action: CMA, IIMA for coordination and preparation of study design)
